## Webinar on "Cultivation and Marketing Process of Medicinal Species"

#### **State Forest Research Institute**

State Forest Research Institute, Jabalpur (SFRI) came into existence on 27<sup>th</sup> June, 1963 for the scientific development of forestry sector in the state of Madhya Pradesh. The institute conducts multidisciplinary forestry research and provides technical advice to the practical problems that are encountered by the field foresters. It also disseminates research findings through training, education, seminars, workshops, participation in public fairs and consultancy services.

Presently, the Ministry of Ayush is Centrally Sponsored Scheme (CSS) of the National Ayush Mission (NAM). Under the 'Medicinal Plants' component of the NAM scheme supporting market-driven cultivation of prioritized medicinal plants in identified clusters/zones within selected districts of States and deployed in a mission mode across the country.

Under this scheme, subsidy at the rate of 75%, 50%, and 30% of the cost of its cultivation is offered for the cultivation of 140 prioritized medicinal plants on farmer's land.

An MOU has been signed by National Medicinal Plants Board (NMPB) with major Ayush and herbal industry bodies for promoting medicinal plant cultivation. Leverage the internet and social media potential for information exchange. Motivation to students in the country and to instill a sense of pride within them.

Kshetriy Sah Suvidha Kendra, Jabalpur Madhya Pradesh, National Medicinal Plants Board (NMPB), Ayush Mantralay, Govt. of India, State Forest Research Institute organized a webinar on "Cultivation and Marketing Process of Medicinal Species" on 31 January 2023 at 11:30 AM on Google Meet.

They have shared a link for registration and webinar a week prior. MIE circulated this link and message to student's group and motivated them for registration and asked them to join webinar along with their parents. MIE have done arrangements to join webinar via projector.

As per the scheme guidelines, the support they offered for:

1. Post-harvest management with forwarding linkages.

- 2. Cultivation of prioritized medicinal plants on farmer's land.
- 3. Establishment of nurseries with backward linkages for raising and supply of quality planting material.
- 4. Primary processing, marketing infrastructure, etc.

24 students have joined this session in college and learnt about Ashwagandha medicinal plant.
